## 1. **DESCRIPTION**:

Showalter Field, 2525 Cady Way, Winter Park, FL 32792;Showalter East Field,2525 Cady Way;Ward Park Field A-1 250 South Perth; Ward Park Field A-2; Ward Park Field B 250 South Perth; Ward Park Field C 250 South Perth (collectively referred to herein as "Showalter Field")

#### 2. **TIME PERIOD**:

I request that you make available to me the following records for the time period between **December 1, 2012 through present**.

#### 3. **MANNER OF PRESENTATION**:

## 4. **RECORD REQUEST:**

Pursuant to chapter 119, I make a request for the following records:

- a. Policies regarding penalties assessed at Showalter Field for persons that fail to register or make a field request within 24 hours of usage. Please include any part of the City Code of Winter Park, Parks and Recreation Rules or procedures that allow for imposition of a \$20.00 penalty for a citizens failure to register a field at Showalter Field 48 hours prior to use.
- b. Any penalties assessed against citizens for failing to register a field at Showalter Field 48 hours prior to use.
- c. Emails, letters, or correspondence from Kesha Jones and any Winter Park Official to citizens or organizations regarding the imposition of a \$20.00 penalty for failing to register the use of Showalter Field 48 hours prior to use.
- d. All applicant forms submitted to the city for persons or organizations that qualify to use Showalter Field.

- i. Contracts awarded to public vendors, private parties, companies, or individuals for the construction of a pipes, water materials, grass, dirt and fill for the improvements of Showalter Field.
- j. Rules, orders, administrative policies, city of the Winter Park Code, and procedures related to the use, operation, maintenance, improvement to Showalter Field.
- k. Rules, orders, administrative policies, city of the Winter Park Code, and procedures related to the rental or registration by citizens or organizations for the use of Showalter Field.
- 1. Monthly or yearly budget for the maintenance of Showalter Field.

The information I obtain through this request will be used to re-open Showalter Field to the public for free use and activity, minimize any penalties assessed to citizens/organization that register for the use of the field, provide for a streamlined and efficient process for field use; alternately, open field B for free use to any citizen at anytime.
